The Government of Nepal has received a grant from the International Development Association toward the cost of Enhanced Vocational Education and Training Project (EVENT) and it intends to apply part of the proceeds of this grant to payments under the Contract for Recruiting Non-Consultancy Services for Management of Voucher Beneficiaries.
2. EVENT now invites Bid from eligible and qualified bidders for Non-Consultancy Services for the survey.

3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the World Bank's Guidelines. Bidding is open to all bidders from Eligible Source Countries as defined in the Guidelines.
4. Interested eligible bidders may obtain further information from Project office and inspect the Bidding Documents from the above office address on office time.
5. Bidders shall meet the Evaluation and Qualification criteria for the contracts as specified in Bidding Documents. All supporting document to be enclosed in bidding must be attested by the authorized Notary Public and the copies of certificate of Notary should be submitted there in.
6. A complete set of Bid documents in English may be purchased by eligible bidders on the submission of a written application to the address above attaching attested copies of (a) firm/NGO registration certificate (b) VAT and PAN registration form and (c) tax clearance certificate, valid for Fiscal Year 2070/71 and upon payment of a non-refundable fee of NRs. 1,000.00 (One thousand rupees only) up-to office time of 2072/07/19 (5 November 2015). The bid document will be available at the address above.
7. Bid must be valid for a period of 90 days and must be accompanied by Bid security amounting NRs. 75,000.00 either in the form of cash voucher or Bank Guarantee issued in favour of this project with validity for 120 days from the date of Bid opening. In case of cash voucher deposited in the bank account number 1201200001002524 at Nepal Rastra Bank, Thapathali.
8. Bid must be delivered to the Procurement Unit, Administration Section, EVENT Project on or before 12:00 noon, 31st day of the first publication of the notice i.e. 2072/07/20 (6 November 2015). Document received after deadline shall not be accepted. Bids shall be sealed in an envelope addressing to the Administration Section, EVENT Project indicating name of the contract, contract identification number, bidder's name and address.
9. Bids shall be opened in the presence of the bidders' representatives who choose to attend at the address above on the last date of bid submission on 2072/07/20 (6 November 2015) at 2.00 PM.
10. If the last day of purchasing, submission and opening of Bid falls on a government holiday then the next working day shall be considered as the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
